


# TECHNICALDATA SHEET

**K12 PET CHEMICAL/CORONA** is a bioriented polyester film with one side chemical coated *(outside)* and the other one corona treated.

This film is suitable to come into contact with food and complies with EN-71. (declarations on request).

### STORAGE

Store the material in a dry location (preferably with RH  $\leq$  50%) at a constant temperature between 10°C and 30°C. Do not leave it exposed to direct sunlight or atmospheric agents. Partially used reels have to be repacked as originally supplied.
