


TECHNICAL DATA SHEET

TK27 MATT

TK27 MATT is a matt bioriented polypropylene film with one side corona treated and the other side coated with adhesive, which is specifically designed for thermal lamination of printed or unprinted paper and cardboard.

This film is suitable to come into contact with food and complies with EN-71 (declarations on request).

STORAGE

Store the material in a dry location (preferably with RH < 50%) at a constant temperature between 10° C and 30° C. Do not leave it exposed to direct sunlight or atmospheric agents.

Partially used reels have to be repacked as originally supplied.
